On February 11, 2016, Resolute Natural Resources Company, LLC (“Resolute”) filed with the Commission a document that it entitled “Request for Public Witness Day On or Near the Areas Affected by Application” (the “Resolute Motion”). The Resolute Motion was filed with the Commission more than twelve days after the deadline set in the Commission’s January 12, 2016, Scheduling Order for parties to provide input on whether a second public witness hearing should be scheduled. (Scheduling Order at 5).

The Resolute Motion, styled as a “Request,” relies upon what purport to be resolutions from two Utah Chapters of the Navajo Nation. The Resolute Motion and attached resolutions are

inaccurate and misleading and contain unsubstantiated and untrue statements and claims that have no bearing on the issues before this Commission. The Navajo Tribal Utility Authority (“NTUA”) respectfully submits that the Commission should treat the Resolute Motion as a motion and that a determination should not be made on the propriety or specifics of an additional public witness hearing without first giving NTUA and any other interested parties an opportunity to respond. In the absence of contrary instructions from the Commission, NTUA thus intends to file a response to the Resolute Motion on or before February 25, 2016, which is 14 days after its filing.
