**Re: Docket No 15-035-84: Application for Approval of Purchase and Transfer Agreement and Power Supply Agreement with Navajo Tribal Utility Authority (NTUA) and Amendment of Certificate of Public Convenience and Necessity**  
*Courtesy Notice of Amended Power Supply Agreement*

On June 10, 2016, the Public Service Commission of Utah (“Commission”) issued its Order Memorializing Bench Rulings Approving Settlement, Amending CPCN No. 1118 and Denying petition to Intervene in the above referenced matter (“Order”). The Order approved the Final Amended Agreements<sup>1</sup> between Rocky Mountain Power and NTUA.

Rocky Mountain Power hereby notifies the Commission that it has entered into an agreement for a third amendment to the Power Supply Agreement (“PSA”) between the Company and the NTUA (“Third Amendment”). The Third Amendment was approved by the Federal Energy Regulatory Commission (“FERC”) on August 3, 2023, in Docket No. ER23-1723-000.

The Third Amendment modifies the points of delivery where the Company will deliver power to NTUA. The PSA included six potential points of delivery, and the Third Amendment removes five of these options, and amends this point of delivery to reflect the Company’s current system. Specifically, the Resolute Energy substation included in the PSA is now in service and is no longer listed as the potential substation. Also, the San Juan switch rack has been replaced with the McCracken metering station, located at the same facility. The Third Amendment does not alter the Purchase and Transfer Agreement or the Certificate of Public Convenience and Necessity.
