**AMENDED NOTICE OF COMMENT PERIOD**

PacifiCorp, dba Rocky Mountain Power (“PacifiCorp”), made a filing on March 30, 2015, requesting changes to Electric Service Schedule No. 140, Non-Residential Energy Efficiency.
