Pursuant to Utah Code Ann. § 54-4-1.5, 54-4a-1 and Utah Admin. Code r746-100 the Utah Division of Public Utilities (“Division”) hereby submits this Initial Response to the Public Service Commission of Utah’s (“Commission”) second Action Request. The Division hereby notifies the Commission of its intention to investigate and make recommendations as per the June 17, 2015 Action Request.

On March 20, 2015 Ticaboo Utility Improvement District (“TUID”) filed revisions to its Tariff No. 1. On March 24, 2015 the Commission issued an Action Request directing the Division to investigate. On April 13, 2014 the Division filed Comments in response to the Action Request recommending that the Commission reject the revised tariffs. On April 24, 2015 the Commission directed TUID to file a response to the Division’s recommendations. TUID filed its

response on May 14, 2015. On May 18, 2015 the Commission issued a second Action Request to the Division to review for compliance and make recommendations.

The Division is providing this initial response to inform the Commission, TUID, and any other interested parties that the Division is conducting further investigation and intends to provide further review and recommendations as well as address legal issues raised in TUID's response in the Division's June 17, 2015 response to the current Action Request.
