Pursuant to R746-100-4, the Division of Public Utilities (Division) files this Motion to Amend Schedule and for Expedited Consideration (Motion). On September 7, 2016 a settlement meeting was held involving Rocky Mountain Power, the Division, the Office of Consumer Services, and the Utah Association of Energy Users (jointly Participants). There are no other parties to the docket and there are no pending intervention requests.

Because of the productive settlement meeting, the Division seeks to amend the schedule by (1) vacating the September 15, 2016 date for filing Rebuttal Testimony; (2) setting September 28, 2016 as the date for filing Rebuttal Testimony instead of as the date for filing Surrebuttal Testimony; and (3) allowing live Surrebuttal Testimony, if needed, at the hearing. The Division is not requesting a change to the Hearing Date or

Discovery turn-around time. The Division is authorized to represent that all the Participants support or do not oppose this Motion.

Due to the approaching Thursday, September 15, 2016, date for filing Rebuttal Testimony, the Division also respectfully requests that the Commission expeditiously consider this Motion.
