ISSUED: November 23, 2016

On July 19, 2016, the Commission issued a notice of filing and comment period, establishing September 2, 2016 as the comment deadline and November 1, 2016 as the reply comment deadline in this docket. The Division of Public Utilities (Division), the Office of Consumer Services (Office), and PacifiCorp, doing business in Utah as Rocky Mountain Power (PacifiCorp), thereafter filed comments on September 2, 2016.

On October 28, 2016, PacifiCorp filed a motion, requesting the Commission amend the reply comment deadline and set a hearing date, which the Commission granted on October 31, 2016. On November 22, 2016, the Division filed a motion requesting to vacate the reply comment and final comment deadlines, noting that a settlement is imminent. The Division represents that the Office and PacifiCorp support the motion. Having reviewed the motion and finding good cause, the Commission vacates the November 29, 2016 reply comment and December 8, 2016 final comment deadlines and sets the following schedule:

**DISCOVERY**
