Rocky Mountain Power (the "Company") hereby notifies the Public Service Commission of Utah ("Commission") that it has entered into an agreement with Cove Mountain Solar 2, LLC to purchase renewable energy output from the solar facility Cove Mountain 2, located in Iron County, Utah on behalf of Facebook, Inc. In the Company's rebuttal testimony filed on August 11, 2016 in the above referenced docket, the Company committed, based on the recommendation of the Office of Consumer Services, to file notice with the Commission if the renewable resource is a resource type other than single-axis tracking solar or a certain term of the contract, as described in the rebuttal testimony, is re-calculated. Neither of these conditions for filing a notice apply, but the Company submits this courtesy notification for informational purposes.
