Dear Commissioners:

Further to the Courtesy Notice of Resource Procurement provided by Rocky Mountain Power (the "Company") on September 9, 2019, the Company hereby notifies the Public Service Commission of Utah that it has entered into agreements with Graphite Solar I, LLC, Horseshoe Solar, LLC and Rocket Solar, LLC to purchase renewable energy output from the solar facilities Graphite, Horseshoe and Rocket, respectively, on behalf of Facebook, Inc. In the Company's rebuttal testimony filed on August 11, 2016 in the above referenced docket, the Company committed, based on the recommendation of the Office of Consumer Services, to file notice with the Commission if the renewable resource is a resource type other than single-axis tracking solar and a certain term of the contract, as described in the rebuttal testimony, is to be re-calculated. Neither of these conditions for filing a notice apply to these facilities, but the Company submits this courtesy notification for informational purposes.
