Fourth Courtesy Notice of Resource Procurement

Dear Commissioners:

Further to the Courtesy Notices of Resource Procurement provided by Rocky Mountain Power (the “Company”) on September 9, 2019, August 13, 2020 and June 30, 2021, the Company hereby notifies the Public Service Commission of Utah that it has entered into two agreements with Faraday Solar B, LLC and Faraday Energy Storage, LLC to purchase renewable energy output from the Faraday Solar and Battery Storage project on behalf of Stadion, LLC, a wholly owned subsidiary of Meta Platforms, Inc.¹ In the Company’s rebuttal testimony filed on August 11, 2016 in the above referenced docket, the Company committed, based on the recommendation of the Office of Consumer Services, to file notice with the Commission if the renewable resource is a resource type other than single-axis tracking solar and a certain term of the contract, as described in the rebuttal testimony, is to be re-calculated. Because there is no change to that certain term of the contract, the requirement for filing a notice does not apply to these facilities, but the Company submits this courtesy notification for informational purposes.


