Re: *In the Matter of the Application of Rocky Mountain Power for Approval of a Renewable Energy Services Contract between Rocky Mountain Power and Facebook, Inc. Pursuant to Tariff Electric Service Schedule 34; Docket No. 16-035-27*

Dear Mr. Backlund,

The Public Service Commission (PSC) reviewed Rocky Mountain Power's (RMP) July 2, 2025, submission of its second compliance filing ("Report") for approval of a renewable energy services contract, containing several confidential and non-confidential attachments. RMP filed the Report in accordance with the PSC's August 29, 2016 Order Memorializing Bench Ruling Approving Renewable Energy Service Contract with Facebook, Inc. ("Order")¹ in this docket and its order dated September 22, 2022 in Docket No. 22-035-30² (together, with the Order, hereinafter referred to as, the "Orders").

¹ On August 29, 2016, the PSC approved the Renewable Energy Service Contract ("RESC") under Schedule 34 with Facebook, Inc. ("Facebook") subject to certain reporting requirements, specifically to provide the first report as soon as practicable following the second full year of collection of data after the customer took initial service under the contract.

² In the PSC's Order dated September 22, 2022 in Docket No. 22-035-30, *Application of Rocky Mountain Power for Approval of Third Amendment to Renewable Energy Service Contract between Rocky Mountain Power and Stadion LLC*, the PSC approved a third amendment to the RESC, wherein parties agreed to various additional safeguards allowing RMP to meet Facebook's renewable energy needs while protecting other RMP ratepayers from subsidizing the service. The third amendment also proposed a reporting schedule, with the first report to be filed by the end of the second quarter of 2023, and requisite reporting thereafter every other year for a period of six years totaling three

The PSC also reviewed the comments submitted by the Division of Public Utilities (DPU), filed on August 18, 2025. DPU represents that it has reviewed the filing and found that all applicable files were included. DPU notes that RMP has switched from the GRID model to Aurora but has provided the necessary Aurora files to meet the requirement. DPU also notes that Requirement 6, comparing rates to Schedule 9, no longer applies since it was only mandatory for the first reporting period. DPU states the files all appear to be reasonable with no issues standing out and recommends the PSC acknowledge RMP's Second Compliance Filing is compliant. No reply comments were filed by the reply deadline of September 2, 2025.

Based on the PSC's review of the Report, DPU's recommendations, and there being no opposition, the PSC acknowledges that the Report complies with the reporting requirements of the Orders.
