PHASE THREE SCHEDULING ORDER AND NOTICE OF HEARING

Pursuant to the Notice of Phase Two Scheduling Conference issued on February 8, 2017, the PSC held a scheduling conference in this docket on February 16, 2017. The parties have stipulated to add a third phase to this proceeding ("Phase Three") in order to adjudicate PacifiCorp's Supplemental Application to Implement Electric Vehicle Incentive and Time of Use Pricing Programs Authorized by the Sustainable Transportation and Energy Plan Act. As the parties stipulated at the February 16 scheduling conference, this Order will establish the schedule for Phase Three. Save for issues related to PacifiCorp's proposed electric vehicle incentive program, nothing in this Order alters or suspends any noticed hearings, conferences or deadlines established in the Phase Two Scheduling Order, Notice of Phase Two Technical Conferences and Notice of Phase Two Hearing.

DISCOVERY AND FILINGS WITH RESPECT TO PHASE THREE

Parties shall respond to discovery requests directed at Phase Three issues within ten calendar days of receipt. Parties shall serve copies of all filings on other parties by electronic mail at or before the time an electronic copy of the document is filed with the PSC. In the event a document filed with the PSC or produced in response to a discovery request cannot reasonably be transmitted by electronic mail, the party filing the document shall file an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy) with the PSC by hand delivery and shall serve an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy) on each applicable party by hand delivery if the party being served is in the same metropolitan area as the serving party, or by overnight courier if the party being served is located in a different metropolitan area from the serving party.
