ISSUED: May 11, 2017

On February 27, 2017, the Public Service Commission of Utah (PSC) issued a scheduling order for phase three of this docket establishing May 11, 2017 as the deadline for parties to file surrebuttal testimony.

On May 10, 2017, PacifiCorp, dba Rocky Mountain Power (PacifiCorp) filed a joint motion for an extension of the surrebuttal testimony filing date from May 11, 2017, to May 16, 2017 (Motion). PacifiCorp indicates that it is authorized to represent that the Utah Division of Public Utilities (DPU), the Office of Consumer Services (OCS), Utah Clean Energy (UCE), Western Resource Advocates (WRA), and ChargePoint, Inc. (ChargePoint) (collectively, the Parties) have reviewed and join the Motion.

The Motion indicates that on May 9 and 10, 2017, PacifiCorp, the DPU, and the OCS met informally to discuss partial settlement of this proceeding. PacifiCorp states the other Parties were informed of the settlement discussions on May 10, 2017, and will be invited to review the joint settlement proposal. The Motion further indicates that Parties are in the process of discussing the details of the partial settlement agreement and plan to meet again on May 11, 2017. While the Parties believe that a settlement agreement will be reached, the Motion indicates there will not be sufficient time for the Parties to finalize the terms of the Stipulation prior to the May 11, 2017 deadline for surrebuttal testimony.
