On June 6, 2019, Western Resource Advocates (“WRA”) filed a Motion to Allow Witness to Appear by Telephone (“Motion”), requesting the Public Service Commission (“PSC”) allow WRA’s witness, Ken Wilson, to testify by telephone at the hearing set for this matter on June 17, 2019. WRA represents it received confirmation from Rocky Mountain Power, the Division of Public Utilities, the Office of Consumer Services, Utah Clean Energy, and the Utah Association of Energy Users that none of these parties objects to the Motion.
