In the Matter of the Application of Rocky Mountain Power to Implement Programs Authorized by the Sustainable Transportation and Energy Plan Act

On June 28, 2019, the Public Service Commission of Utah ("Commission") issued its Report and Order approving Rocky Mountain Power's ("Company") request to implement three new programs under the Sustainable Transportation and Energy Plan Act ("STEP Act"): (1) the Power Balance and Demand Response to Optimize Charging at Intermodal Hub Project; (2) the Wasatch Development Partnership Project for Battery Demand Response; and (3) the Advanced Resiliency Management System Project ("Order"). As part of the approval, the Commission adopted several reporting requirements that were proposed by interested parties.

For the Wasatch Development Partnership Project for Battery Demand Response, the Company committed to provide the permit from the local government authority once available, which was included as a requirement on page 6 of the Order. In accordance with the Company's commitment and the Order, the Company hereby submits the Approved Building Permit for the Solar Rooftop Photovoltaic and Battery System from the City of Herriman as Confidential Attachment A.
