Dear Mr. Widerburg:

Rocky Mountain Power (the “Company”) hereby submits for filing the following reply comments pursuant to the Commission scheduling order dated September 28, 2016 in the above referenced matter.

In comments provided on November 3, 2016, the Division of Public Utilities (“DPU”) concluded that the terms of the Tesoro Power Purchase Agreement (“Agreement”) comply with the Commission’s guidelines and order in Docket Nos. 03-035-14 and 12-035-100. The DPU recommended that the language in the Agreement referencing the 2010 Protocol be updated to the 2017 Protocol. The DPU further recommended that the Commission order the Company to provide with future power purchase agreement filings, the GRID outputs and Excel spreadsheets supporting the price calculations and spreadsheets showing avoided line loss calculations. Further, the DPU recommended that the Company continue to provide, at least quarterly, hourly power purchased reports.

Pursuant to the DPU recommendation, on November 10, 2016 the company filed an updated Agreement modifying language in Section 2.1 of the Agreement referencing the 2010 Protocol.

Also pursuant to the DPU recommendations the company agrees to provide, concurrent with future power purchase agreements filings, the supporting GRID outputs and spreadsheets in the requested format. Finally, consistent with the DPU recommendations the Company commits to continue to provide, at least quarterly, a report of hourly power purchased.


