NOTICE OF FILING

On September 27, 2016, Blyncsy, Inc. (Blyncsy) filed a formal complaint against Rocky Mountain Power, a public utility. Blyncsy alleges that it qualifies under Rocky Mountain Power's tariff and all applicable administrative rules as an attaching entity. Therefore, Blyncsy alleges that it is entitled to attach devices that track and record traffic patterns to Rocky Mountain Power's utility poles, including secondary poles and street lighting poles. Blyncsy alleges that Rocky Mountain Power has wrongfully refused to enter into an attachment agreement.

Rocky Mountain Power may submit a response to Blyncsy's complaint no later than **Thursday, October 27, 2016**. Blyncsy may file a reply no later than **Monday, November 14, 2016**.
