The Division has not ignored its action request deadline. If you review the request itself, you will see language stating that it is deemed withdrawn if the Commission issues a notice or scheduling order establishing a comment period. The Commission issued a notice of comment period on December 29, 2016, thereby withdrawing the action request. In its December 29, 2016 notice of comment period, the Commission did not require the Division to file a response to the complaint. Therefore, the Division is not required to participate in this matter.

Please take note that the statutes governing this proceeding prohibit you from contacting me without including Rocky Mountain Power in the communication. I have copied counsel for Rocky Mountain Power here, and I will include this e-mail chain in the record so as to document the ex parte communication. See Utah Code § 54-7-1.5.
