SCHEDULING ORDER, NOTICE OF
HEARING, AND NOTICE OF
PUBLIC WITNESS HEARING

ISSUED: June 27, 2016

On June 17, 2016, PacifiCorp, doing business as Rocky Mountain Power (PacifiCorp), filed Advice No. 16-08, requesting approval of Electric Service Schedule No. 34, Renewable Energy Tariff (Schedule 34). PacifiCorp's proposed Schedule 34 is in response to the Utah Legislature's passage of S.B. 115, effective May 10, 2016, which is codified in relevant part at Utah Code Ann. § 54-17-806. Although PacifiCorp filed proposed Schedule 34 as an advice letter, which under Commission rule would typically require the Commission to act within 30-days of the filing date or otherwise suspend the tariff before the expiration thereof (*see* Utah Admin Code R746-405(2)(E)(2)), suspension is unnecessary even though the agreed upon schedule set forth below extends beyond 30 days, because Schedule 34 proposes a service or product not previously offered (*see* Utah Code Ann. § 54-17-12(5)(c)). Thus, the 30-day action requirement is inapplicable.

The Commission held a scheduling conference in this docket on June 24, 2016. In accordance with the discussion at the conference, the parties agreed to the following schedule:

DISCOVERY
