Pursuant to R746-100-4, the Division of Public Utilities ("Division") files this Motion to Amend Schedule by Extending Filing Date for Direct Testimony and Rebuttal Testimony, and for Expedited Consideration ("Motion"). On July 22, 2016, a discussion was held involving Rocky Mountain Power, the Division, the Office of Consumer Services, the Utah Association of Energy Users, Salt Lake City Corporation, Wal-Mart Stores, Inc., Enyo Renewable Energy, LLC, and Interwest Energy Alliance (jointly "Participants"). Because of this discussion, the Participants desired to request that the
