ISSUED: August 4, 2016

On July 26, 2016, PacifiCorp dba Rocky Mountain Power (“PacifiCorp”) filed Advice No. 16-09, proposing revisions to Electric Service Schedule No. 114, Air Conditioner Direct Load Control Program (A/C-DLC) – (Cool Keeper Program) to be effective September 1, 2016. The same date, the Commission issued an action request to the Division of Public Utilities (“Division”), requesting the Division investigate the proposed changes and provide a response to the Commission on or before August 10, 2016.

On July 28, 2016, PacifiCorp filed a Request for Revised Effective Date and Extended Comment Period, representing the Office of Consumer Services (“Office”) had expressed a desire to PacifiCorp to comment on the filing but required additional time. To accommodate the Office, the Request asks the effective date of PacifiCorp’s proposed tariff changes be revised to December 1, 2016. The Request further asks the Commission allow parties to file comments by September 30, 2016 and to submit reply comments by November 1, 2016.

Good cause appearing, the Commission grants the Request. The tariff changes proposed in Advice No. 16-09 are suspended and shall not take effect until and unless approved by order of the Commission. Any interested party may submit comments on or before **Friday, September 30, 2016** and may submit reply comments on or before **Tuesday, November 1, 2016**.
