Please accept my public comment on #16-035-T14, Rocky Mountain Power's suggested rate structure which dramatically increases the costs to new net metering users.

RMP suggests that net metering customers add costs to their system. Part of the commission's consideration should be that RMP puts up big advertisements telling all of its customers how noble it is because it connects RMP customers to a large number of solar panels. These have been in my area on UTA busses for months. The ad counts the solar panels on my roof and those of other net metering customers. It does this without my approval, however, my comment is not to complain. Instead, the commission should calculate the value of the benefit that RMP receives all over our state because their customers believe that a percentage of their power comes from solar. That value comes directly from the costs borne by net metering customers. I am not considering legal action against RMP for using my solar panels in their advertisements, however they are deriving significant value.
