ISSUED: December 9, 2016

On November 9, 2016, PacifiCorp initiated this docket by filing Advice No. 16-13, which proposes revisions to Schedule 135, Net Metering Service and a new Schedule 135A, Net Metering – Transition Service ("Tariff Changes").

On December 9, 2016, PacifiCorp filed a letter in which it "recommends the Commission exercise its statutory prerogative to suspend the [Tariff Changes] pursuant to Utah Code Ann. § 54-7-12(5) & (6) while interested stakeholders continue to seek mutually acceptable resolutions." Because this recommendation is not inconsistent with the comments and replies we have received from others in this docket, we accept PacifiCorp's recommendation and suspend the Tariff Changes.

PacifiCorp further notes in the December 9, 2016 letter that it "will notify the Commission if a stipulation is reached or if the attempt to resolve this matter becomes unfruitful." We will await that notification before holding further proceedings in this docket. This Order does not modify the schedule separately established in Docket No. 14-035-114.
