Dear Mr. Widerburg:

Empire Electric Association plans to update its meter tampering fee and institute a meter reading fee. The meter tampering fee is charged when Empire discovers that someone has tampered with a meter in order to steal power. The present meter tampering fee is \$50.00 and Empire plans to increase this fee to \$250.00 in order to more accurately recover the costs to deal with tampering events. The meter reading fee is a new fee that will apply only to those who opt-out of having their meter read remotely. This fee will be \$54.80 per quarter and is meant to recover costs associated with manually reading a meter. The dollar amount was determined by estimating the costs to manually read a meter. Those who have their meter read remotely will not be charged a meter reading fee. Empire's board of directors approved these changes at their March 17, 2017 meeting.

These changes are scheduled to go into effect on June 1, 2017. A public meeting to discuss these changes is scheduled for Monday, May 8th, 2017 at 10:00am. The meeting will be held at Empire's main office located at 801 North Broadway, Cortez, Colorado.

Empire has also created a new tariff sheet, Sheet 17, that lists the fees we charge. This was done so that all our fees could be listed in one location. Although this is a new sheet, only the meter tampering and meter reading fees have been updated. The rest of the fees in this sheet were approved with our Rules and Regulations in 1988 and have not changed.
