NOTICE OF FILING AND COMMENT PERIOD

On March 9, 2017, PacifiCorp, doing business as Rocky Mountain Power ("PacifiCorp"), filed a notice and request ("Request") for extension deadlines related to the requirement of parties to execute a power purchase agreement ("PPA") within five months after the proposed PPA is provided by PacifiCorp to the developer and within six months after indicative pricing was provided. PacifiCorp's Request explains that extenuating circumstances have transpired during the on-going negotiations of the PPA between PacifiCorp and Sustainable Power Group ("sPower"), the owners of the Glen Canyon A project.<sup>1</sup>

Any interested party may submit comments on PacifiCorp's Request on or before **Friday, March 17, 2017**, and reply comments may be submitted no later than **Friday, March 24, 2017**.
