NOTICE OF FILING AND COMMENT PERIOD

On May 1, 2018, Rocky Mountain Power, dba PacifiCorp ("PacifiCorp") filed its Update to its 2017 Integrated Resource Plan ("Update"). Any interested party may submit comments on the Update on or before **Monday, July 30, 2018**, and reply comments may be submitted on or before **Monday, September 10, 2018**. To the extent Utah Admin. Code R746-430-1(2)(a) contemplates the holding of a scheduling conference to establish these deadlines, the Public Service Commission ("PSC") waives the requirement. If any party objects to the deadlines established herein or otherwise wishes the PSC to hold a scheduling conference related to the Update, the party may submit a request for scheduling conference to the PSC, in writing, on or before **Monday, June 11, 2018**.

Parties shall respond to requests for data or discovery within 14 calendar days until July 30, 2018 and shall respond as expeditiously as is practicable thereafter and preferably within seven calendar days. In the event a document filed with the PSC or produced in response to a discovery request cannot reasonably be transmitted by electronic mail, the party disclosing the document shall provide an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy).
