On June 16, 2017, PacifiCorp, dba Rocky Mountain Power (PacifiCorp), filed an application for approval of solicitation process for up to approximately 1,270 MW of new wind resources capable of interconnecting to, and/or delivering energy and capacity across, PacifiCorp's transmission system in Wyoming. PacifiCorp requests an order from the Public Service Commission of Utah (PSC) by August 22, 2017, and proposes certain comment and reply comment deadlines in its application.
