# Re: **Reply Comments**

In the Matter of Rocky Mountain Power's Demand-Side Management 2016 Annual Energy Efficiency and Peak Load Reduction Report Docket No. 17-035-32

On June 7, 2017, the Public Service Commission of Utah ("Commission") issued an Amended Notice of Filing and Comment period in the above referenced matter, allowing parties to file comments by July 6, 2017, and reply comments by July 20, 2017. The Division of Public Utilities ("DPU"), Office of Consumer Services ("OCS"), Utah Clean Energy ("UCE"), and Southwest Energy Efficiency Alliance ("SWEEP") filed comments July 6, 2017. UCE's and SWEEP's comments were filed jointly. Rocky Mountain Power (the "Company") provides these reply comments in response to party comments.

The DPU and OCS both recommended in their comments that the Commission acknowledge the Company's revised report as complying with report requirements.

UCE/SWEEP made several requests and recommendations in their comments, all of which are items typically covered during Steering Committee meetings. It should be noted that many of the recommendations/requests made by UCE/SWEEP have been previously discussed in Steering Committee meetings. Notwithstanding, the Company intends to address UCE/SWEEP's comments at the next Steering Committee meeting.

The DPU and OCS also commented on target achievement, net benefit fluctuation, and reported capacity reduction. The Company will also discuss these items at the next Steering Committee meeting.
