Dear Mr. Lively:

The Public Service Commission (PSC) reviewed the June 1, 2017 filing by PacifiCorp, dba Rocky Mountain Power (PacifiCorp), of its Utah Solar Incentive Program 2017 Annual Report (Report) presenting Program results through May 17, 2017. The Report was filed in compliance with the PSC's October 1, 2012 Report and Order in Docket No. 11-035-104 authorizing PacifiCorp to implement a solar incentive program.¹ The Report was also filed in compliance with the PSC's September 25, 2014 Order in Docket No. 14-035-71.² Additionally, the PSC reviewed the July 3, 2017 comments filed by the Division of Public Utilities (DPU) and Utah Office of Consumer Services (OCS). No reply comments were filed.

The DPU provided a summary of the Program including reporting requirements and recent PSC decisions. The DPU concluded the Report complies with the PSC's reporting requirements and recommends the PSC acknowledge the Report. The OCS commented on issues including surrendered deposits, generation data for large systems, Cool Keeper program participation, and Renewable Energy Credits (RECs). Like the DPU, the OCS recommends acknowledgment, but also recommends future reports include information related to the disposition of PacifiCorp's share of RECs from the Program.
