Pursuant to Public Service Commission Rule R746-1-301, comes now, Rocky Mountain Power (the "Company"), with a motion requesting the Public Service Commission of Utah (the "Commission") amend the procedural schedule approved and adopted in this docket as set forth in Paragraph 5 below. In support of its Motion, Rocky Mountain Power states as follows:

1. Pursuant to a Notice of Scheduling Conference issued June 8, 2017, the Commission held a scheduling conference in this docket June 15, 2017. During the scheduling conference, the parties stipulated to the following schedule:

2. On June 20, 2017, the Commission issued its Scheduling Order and Notice of Hearing in this docket approving and adopting the foregoing schedule.

Following the scheduling conference, on July 24, 2017, the Company filed a motion to dismiss Glen Canyon's request for agency action ("RMP Motion"); on August 11, 2017, Glen Canyon filed its response to the RMP Motion as well as motion for preliminary injunction ("PI Motion"), and the Division of Public Utilities filed a response to the RMP Motion.

4. After subsequent discussions, the parties in the docket determined that it is reasonable to amend the procedural schedule given the motion practice that has evolved in the case.

5. The Company requests that some of the dates in the currently approved procedural schedule be vacated and that the Commission adopt and approve the following dates instead:




