ORDER GRANTING MOTION TO AMEND PROCEDURAL SCHEDULE

On June 20, 2017, the Public Service Commission ("PSC") issued a Scheduling Order and Notice of Hearing, establishing an adjudication schedule and hearing date for this docket.
