**CONSOLIDATION OF DOCKET NOS. 17-035-T07 AND 17-035-37, AND SUSPENSION OF PHASE II SCHEDULE IN DOCKET NO. 17-035-T07**

On July 20, 2017, Utah Clean Energy (UCE), filed a motion to suspend the Phase II schedule in Docket No. 17-035-T07 and to consolidate it with the schedule in Docket No. 17-035-37 (UCE's Motion). The Public Service Commission of Utah (PSC) issued a notice of filing and request to make objections to UCE's Motion known at the July 26, 2017 scheduling conference planned in Docket No. 17-035-37. All parties present at the scheduling conference voiced their mutual agreement that these dockets should be consolidated and the earlier scheduling order issued in Docket No. 17-035-T07 suspended and replaced with the scheduling order set forth below. Accordingly, for the reasons expressed in UCE's Motion, and there being universal agreement among the parties with UCE's Motion, we grant UCE's Motion to suspend the Phase II schedule in Docket No. 17-035-T07 and enter the scheduling order, agreed to by the parties, set forth below. The PSC notes, to the extent parties filed testimony or comments in Docket No. 17-035-T07 before issuance of this order, those parties should refile their testimony in accordance with the scheduling order entered below.

**DISCOVERY**

Discovery turn-around times are 14 calendar days until October 3, 2017, then 10 days or best efforts thereafter. Parties shall serve copies of all filings on other parties by electronic mail at or before the time an electronic copy of the document is required to be filed with the PSC. In the event a document filed with the PSC or produced in response to a discovery request cannot reasonably be transmitted by electronic mail, the party filing the document shall file an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy) with the PSC by hand delivery and shall serve an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy) on each applicable party by hand delivery if the party being served is in the same metropolitan area as the serving party, or by overnight courier if the party being served is located in a different metropolitan area from the serving party.

their witnesses in attendance and prepared to testify. Parties also should reserve **Tuesday, December 5, 2017**, in the event the hearing lasts more than one day.
