ISSUED: January 29, 2018

The Public Service Commission (“PSC”) gives notice it will hear oral argument on the Division of Public Utilities’ and the Office of Consumer Services’ (collectively, “Moving Parties”) Motion to Vacate Remaining Schedule and Request for Expedited Treatment (“Motion”), filed January 19, 2018. The oral argument will take place on **Tuesday, February 6, 2018 at 1:30 p.m.**, Fourth Floor Hearing Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.

The Moving Parties and those who support their Motion should come to oral argument prepared to identify the deficiencies they believe continue to exist in PacifiCorp dba Rocky Mountain Power’s (“RMP”) Application for Approval of a Significant Energy Resource Decision and Voluntary Request for Approval of a Resource Decision (“Application”) and to specifically identify which, if any, deficiencies render RMP’s Application incomplete under Utah Admin. Code R746-430. These parties should further come prepared to discuss the materiality of any such deficiencies and why they require an extension of the adjudication schedule in this docket.

RMP should come to the oral argument prepared to explain the reason any deficiencies continue to exist in the Application, including, but not limited to, required supporting materials. RMP should further come prepared to explain, with reasonable specificity, when it must

commence construction on its projects and to provide a date by which failure to conclude the litigation of this docket would put the availability of applicable tax credits or other benefits upon which RMP seeks to capitalize at risk.

To spare the parties from having to comply with imminent deadlines pending the Motion, the PSC suspends the February 6, 2018 deadline for “Intervenor Direct Testimony in Response to RMP Supplemental Testimony on RFP Results” and the February 16, 2018 deadlines for “All Parties’ Surrebuttal Testimony” and “All Parties’ Rebuttal Testimony in Response to Intervenor RFP Testimony,” as established in the PSC’s Scheduling Order issued July 27, 2017. If the Motion is ultimately denied, the PSC will issue an amended scheduling order reestablishing practical deadlines for this testimony.

Individuals wishing to participate by telephone should contact the PSC two days in advance by calling (801) 530-6716 or (toll-free) 1-866-PSC-UTAH (1-866-772-8824) to receive a bridge number and participant passcode. Participants attending by telephone should then call the bridge number five minutes before the hearing, entering the passcode followed by the # sign to ensure participation.
