ORDER CLARIFYING AMENDED
SCHEDULING ORDER

ISSUED: March 6, 2018

On March 5, 2018, counsel for the Division of Public Utilities (“DPU”) submitted a written inquiry to the Public Service Commission (“PSC”), copying all parties and inquiring when “surrebuttal to Rocky Mountain Power’s [“RMP”] Rebuttal Testimony filed along with its Supplemental Direct Testimony” is due.

In response to the DPU’s question, the PSC clarifies its February 13, 2018 Amended Scheduling Order (“Scheduling Order”) as follows: surrebuttal testimony in response to the rebuttal testimony RMP filed on January 16, 2018 must be filed on or before April 17, 2018 (which is the same date rebuttal testimony on RMP’s supplemental testimony on RFP results is due). This clarification does not otherwise amend the Scheduling Order in any respect. All deadlines and the hearing date enumerated in the Scheduling Order are preserved.
