Having reviewed Mr. Seftel's Formal Complaint, PacifiCorp dba Rocky Mountain Power's ("RMP") Answer and Motion to Dismiss ("Motion"), and the Division of Public Utilities' comments, the Public Service Commission ("PSC") finds questions of fact exist with respect to Mr. Seftel's Formal Complaint. The Motion to Dismiss is denied.
