NOTICE OF FILING

On September 5, 2017, Brent E. Hill filed a formal complaint against Rocky Mountain Power (RMP), a public utility. Mr. Hill alleges that RMP owns utility poles within a subdivision where Mr. Hill owns property, but that the utility poles are located outside of the recorded utility easement. Mr. Hill alleges that, if RMP's poles were within the recorded utility easement, RMP would be able to serve his property without incurring costs for additional infrastructure. However, given the current location of the poles, RMP has informed Mr. Hill that electric utility service cannot be extended to his property unless easements are granted by Mr. Hill's neighbors to RMP. Mr. Hill alleges that RMP: (a) has improperly required him to obtain the necessary easements and to pay any associated costs; and (b) has improperly assessed to Mr. Hill all infrastructure costs that might be incurred in bringing electric utility service to his property.

NOTICE OF COMMENT PERIOD

RMP may submit a response to Mr. Hill's complaint no later than **Friday, October 6, 2017**. Mr. Hill may file a reply no later than **Monday, October 23, 2017**.
