On September 5, 2017, Brent Hill (Mr. Hill) filed a formal complaint against Rocky Mountain Power (RMP). On September 6, 2017, a Notice of Filing and Comment Period was issued, setting forth a response deadline of October 6, 2017 to allow RMP to respond to Mr. Hill's complaint, and a reply deadline of October 23, 2017 to allow Mr. Hill to reply to RMP's response.

On October 6, 2017, Rocky Mountain Power filed an Answer and Motion to Dismiss (Motion). Sometime thereafter, a new presiding officer was assigned to this docket, and it does not appear that response and reply deadlines have been established concerning RMP's Motion. Accordingly, to ensure due process is afforded to the parties to this docket, the PSC adopts the following revised scheduling order:
