ORDER

On December 12, 2017, the PSC dismissed Mr. Hill's complaint against Rocky Mountain Power (RMP) in this docket. Unbeknownst to the PSC at the time of its December 12, 2017 Order, Mr. Hill had served a response to RMP's October 6, 2017 Answer and Motion to Dismiss as ordered by the PSC on November 22, 2017. Mr. Hill timely served his response on RMP and the Division of Public Utilities, but failed to file his response with the PSC. We find Mr. Hill's error harmless and, accordingly vacate our December 12, 2017 Order dismissing his complaint.
