NOTICE AND AMENDMENT TO
ACTION REQUEST

ISSUED: September 29, 2017

On September 27, 2017, Clenera, LLC, on behalf of 1.21 GW LLC ("Clenera") filed a letter with the Public Service Commission ("PSC") stating it "wishes to modify [the] designation [of its filing] from 'Complaint' to a 'Notice and Request' and modify the Action Request to 'Review Notice and Make Recommendations.'"

Aside from the docket's cosmetic designation, Clenera does not identify any distinction in procedural treatment it seeks aside from that established in the previously issued Action Request and Notice of Filing and Comment Period. Although we anticipate the Division of Public Utilities ("DPU") would have made a recommendation without such direction, to alleviate any concern Clenera may have about the DPU being specifically instructed to "make a recommendation" as opposed to "analyze [Clenera's] complaint," we amend the Action Request and direct the DPU to make a recommendation with respect to Clenera's filing.

If Clenera seeks any additional procedural relief from the PSC, Clenera must file a motion explaining the procedure it seeks to implement and the basis under applicable law for doing so.
