Having reviewed the Formal Complaint of Clenera, LLC, on behalf of 1.21 GW LLC (“Clenera”) and PacifiCorp dba Rocky Mountain Power’s (“RMP”) Response to the Formal Complaint and Motion to Dismiss (“Motion”), the Public Service Commission (“PSC”) finds questions of fact exist as to whether Clenera is entitled to the relief it requests in its Formal Complaint. The Motion to Dismiss is denied.

NOTICE OF HEARING

Having reviewed the Formal Complaint, RMP’s response and comments from the Division of Public Utilities, the PSC finds the issues presented warrant a hearing. Accordingly, the PSC will conduct a hearing in this docket on **Thursday, December 21, 2017, beginning at 9:00 a.m. (MDT)**. The hearing will be held in the **Fourth Floor Hearing Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah**. All parties must have their witnesses in attendance and prepared to testify.
