In the event issues remain to be resolved subsequent to the initial round of dispositive motion practice, the attendees asked the PSC notice a second scheduling conference after an order(s) issues on the motion(s).

### NOTICE AND MEMORIALIZATION OF AGREEMENT TO EXTEND TIME FOR RESOLUTION OF REQUEST FOR DECLARATORY RULING

RMP initiated this docket on October 5, 2017 by filing its Request for Agency Action and Petition for Declaratory Ruling ("Request"). Utah Code Ann. § 63G-4-503(7) provides "[u]nless the petitioner and the agency agree in writing to an extension, if an agency has not issued a declaratory order within 60 days after receipt of the petition for a declaratory order, the petition is denied." Therefore, the Request would be denied by operation of statute after December 6, 2017 absent an agreement to extend. The stipulated briefing schedule for dispositive motions outlined above precludes the possibility this docket will be resolved within 60 days.

During the scheduling conference, RMP's counsel, Yvonne Hogle, represented RMP would agree to an extension of the statutory period and asked the PSC to similarly agree. Based on the attendees' stipulated schedule and good cause appearing, the PSC's presiding officer assented. Therefore, the PSC gives notice of and memorializes the agreement to extend the statutory period for resolution of the Request beyond 60 days for so long as is required to complete the dispositive motion practice and any additional process the PSC subsequently determines is necessary.
