Procedural Schedule**



Rocky Mountain Power, a division of PacifiCorp, (“Rocky Mountain Power” or “PacifiCorp”), under the Public Service Commission Administrative Procedures Act Rules, R746-1-301, hereby moves the Public Service Commission of Utah (“Commission”) to stay the deadlines established in the Order Granting Unopposed Motion to Extend Procedural Schedule (“Order Extending Schedule”), issued November 17, 2017 in this Docket (“Motion”). Rocky Mountain Power is authorized to represent that the Utah Division of Public Utilities (“Division”) and the Office of Consumer Services (“Office”) do not oppose this Motion. In support of this Motion, Rocky Mountain Power states that since the Commission issued the Order Extending Schedule, the parties have reached an agreement in principle and continue to work on a settlement agreement. 
