ISSUED: December 15, 2017

On December 15, 2017, PacifiCorp dba Rocky Mountain Power (“RMP”) filed an Unopposed Motion to Stay Procedural Schedule (“Motion”) in this docket. RMP states it is authorized to represent that the Utah Division of Public Utilities and the Office of Consumer Services (collectively with RMP, the “Parties”) do not oppose this Motion. RMP indicates that since the PSC issued its Order Granting Unopposed Motion to Extend Procedural Schedule on November 17, 2017 in this docket, the Parties have reached an agreement in principle and are working on a settlement agreement.
