On February 8, 2018, Salt Lake City Corporation petitioned for leave to intervene in Phase I and Phase II of this docket.

Because no party has objected to the petition and good cause otherwise appears to exist, the Public Service Commission (PSC) will grant intervention. Intervention is conditioned upon the intervenor's representatives participating in this matter adhering to the Utah Standards of Professionalism and Civility adopted by the Utah Supreme Court October 16, 2003. Leave to intervene is granted to Salt Lake City Corporation. Intervention is granted as described above.
