ORDER AMENDING STARTING  
TIME OF APRIL 17, 2018 HEARING

---

ISSUED: March 19, 2018

On March 9, 2018, the Public Service Commission of Utah (PSC) issued a Notice and Request for Comments requesting feedback from parties concerning the 9:00 a.m., April 17, 2018 hearing scheduled in this docket as it relates to the 9:45 a.m., April 17, 2018 oral argument set before the Utah Supreme Court.<sup>1</sup> The PSC subsequently received comments from two parties -- the Division of Public Utilities (DPU) and the Office of Consumer Services (OCS). The DPU expressed it would likely be able to accommodate both the hearing and oral argument on the same day; however, it prefers not to “overlap” the hearing and oral argument and suggested rescheduling the PSC hearing later in the day on April 17, 2018 and continuing into the evening if necessary. The OSC, likewise, expressed a willingness to accommodate both the hearing and oral argument on the same date. No other party commented.<sup>2</sup>

We appreciate the comments filed and the willingness of both the DPU and OSC to accommodate the PSC hearing and the appellate argument scheduled for April 17, 2018. The PSC has, nevertheless, determined that rescheduling the time of the hearing in this docket would best serve those who will be appearing in both hearings. Accordingly, the PSC amends the **Phase I Scheduling Order and Notice of Hearing**, issued December 12, 2017, as follows:
