ISSUED: April 3, 2018

On March 19, 2018, the Public Service Commission of Utah (PSC) issued an Order Amending Starting Time of April 17, 2018 Hearing from 9:00 a.m. to 1:00 p.m. to avoid a conflict with an oral argument set before the Utah Supreme Court on the same day. Subsequently, the Utah Supreme Court granted a party's motion to reschedule oral argument, thereby eliminating the need to amend the starting time of the PSC hearing in this docket from its original scheduled time of 9:00 a.m. Therefore, we amend the starting time of the hearing to 9:00 a.m. The PSC recognizes that certain travel schedules may have already been established to accommodate parties' participation in the hearing at 1:00 p.m. and, to the extent any party's travel schedule cannot be rescheduled at this time, the PSC will allow parties to appear and give testimony at 1:00 p.m. As such, the PSC amends the **Phase I** Scheduling Order and Notice of Hearing, issued March 19, 2018, as follows:

**NOTICE OF HEARING**
