AMENDED NOTICE OF HEARING

ISSUED: April 28, 2020

On March 23, 2020, the Public Service Commission (PSC) issued a Notice of Comment Period Regarding Hearing Date, requesting comments from the parties as to whether they objected to amending the start date of the hearing from September 28, 2020 to September 29, 2020, owing to a religious holiday. The PSC received comments in support of amending the start date from the Division of Public Utilities, Utah Clean Energy, the Office of Consumer Services, Rocky Mountain Power, and Vivint Solar. No party filed comments in opposition. Based on the parties' comments and good cause appearing, the hearing will commence on Tuesday, September 29, 2020 rather than Monday, September 28, 2020. All other dates enumerated in the PSC's Phase II Scheduling Order, Notice of Public Witness Hearing, and Notice of Hearing, issued January 16, 2018, remain in effect.

AMENDED NOTICE OF HEARING

The PSC will conduct a hearing in **Phase II** of this docket, beginning on **Tuesday, September 29, 2020 and continuing, as necessary, September 30, 2020 through October 2, 2020. Each day the hearing will begin at 9:00 a.m. The hearing will take place in the Fourth Floor Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.** Parties should also reserve October 5th through the 9th, 2020, in the event the hearing has not concluded by October 2, 2020. All parties must have their witnesses in attendance and prepared to testify.
