This proceeding will determine the credit that Utah residential solar customers receive for electricity generated by solar panels that the household does not use that is then exported to Rocky Mountain Power's ("RMP") grid. This export rate will apply to new customer-generators beginning in 2021 and will impact existing customer-generators beginning in 2032-2035.
