Good afternoon,

To see RMP want to do this again is very frustrating, as many solar co's worked with RMP several years to come up with a net meter export compromise that was supposed to put an end to this issue.

The current proposal is really outrageous, as was the first. The reality is that exported Kilowatt hours from residential systems do not just vanish, they go into the grid and get used by another meter, for which RMP bills at full bore. If RMP were willing to replace those kilowatt hours to the residential system overnight at wholesale if they are paying wholesale for them I'd have no problem with it, but that is not what is happening. Those exported hours ARE being sold at full rate to other customers, there is no denying that is true.

It was very equitable to trade kWh exported for those used after sundown. Kwh to kwh. The first net meter export rate reduction was bad enough, but this proposal should be firmly rejected as a travesty for the residential solar owner. The right thing to do would be to restore the arrangement before the net meter rate compromise, put things back the way they were before.
