NOTICE, NOTICE OF PRE-HEARING CONFERENCE, AND AMENDED NOTICE OF HEARING AND PUBLIC WITNESS HEARING

ISSUED: September 8, 2020

The Public Service Commission of Utah (PSC) provides notice of procedural and technological issues related to the evidentiary hearing scheduled for September 29, 2020 through October 9, 2020, and the public witness hearing scheduled for October 5, 2020 at 2:00 p.m. (MDT). The PSC also gives notice of a pre-hearing conference on Thursday, September 24, 2020 at 3:00 p.m. (MDT) to address technology issues for the evidentiary hearing.

EVIDENTIARY HEARING

On or before Monday, September 21, 2020, the PSC will email a Google Meet link and telephone number to each attorney who has made an appearance in this docket. Those attorneys should provide the connection information to their witnesses. To accommodate hearing management, the PSC requests that hearing participants do not distribute that connection information to anyone other than attorneys and witnesses who will be participating in the hearing.

The PSC will also stream the hearing through the PSC YouTube channel, which is available by link from the PSC website. Any interested person may view and listen to the hearing through that means without a need to connect to the video conference. The YouTube stream of the hearing will be available live, and will also be archived and available after the hearing is concluded.

The PSC requests that attorneys and witnesses make themselves available by both video and audio during the portions of the hearing in which they will be actively participating. Participants are free to deactivate video, and should always mute audio, when not actively participating. Participants also may find it useful to have headphones or earbuds available in the event of feedback, since at times a participant's microphone may pick up the participant's voice twice, once from the person and another time from the computer speakers.

In the event of unresolvable technological problems related to the hearing's video conferencing, the PSC will have a separate conference telephone number available to continue the hearing by audio only.

The same Google Meet link and telephone number will be used for each day of the evidentiary hearing.

PUBLIC WITNESS HEARING

The PSC will continue to accept written public comment, and encourages anyone who is able to use that means to provide comment to the PSC. The PSC will also conduct a public witness hearing on Google Meet as scheduled in this docket. That hearing will use a different Google Meet link and telephone number from the evidentiary hearing.

Anyone who wishes to provide public comment at this hearing must email the PSC at psc@utah.gov to schedule an appointment. Requests for an appointment must be emailed no later than Wednesday, September 30, 2020. Requests should have "Request to provide public comment in Docket No. 17-035-61" in the subject line and the full name of the requester in the email to help ensure the requests are processed correctly.

Requesters will receive an email with their scheduled time and the Google Meet connection information. Public comment will be limited to 3 minutes except that any person who needs more time than that may return to the hearing after all other members of the public have provided their scheduled comments. Individuals providing public comment are free to connect by either video or audio only, but should keep their audio muted except when providing public comment.

Attorneys who have made an appearance in this docket will be emailed the connection information for the public witness hearing during the first week of the evidentiary hearing.

The public witness hearing will also be streamed through the PSC YouTube channel. The PSC encourages members of the public to listen to the hearing through that medium when they are not presenting their own comments.
