On December 23, 2020, the Public Service Commission (PSC) issued an Order on Agency Review or Rehearing and Notice of Virtual Scheduling Conference (“Order”), granting rehearing on a narrow and specific set of issues enumerated in the Order (“Limited Rehearing Issues”). NOTICE OF HEARING

The PSC will conduct a hearing in this docket on **Tuesday, March 9, 2021, beginning at 9:00 a.m.** The hearing will be held in the **Fourth Floor Hearing Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.** All parties must have their witnesses in attendance and prepared to testify. Consistent with Utah Code Ann. § 52-4-207, the chair of the PSC may make a determination that holding the hearing at an anchor location would result in

substantial risk to the health and safety of those present. If such a determination is made, the PSC will issue a notice within 30 days of the hearing providing instructions on how to participate in a virtual hearing in accordance with the statute.¹ Otherwise, individuals wishing to participate by telephone should contact the PSC two days in advance by calling (801) 530-6716 or (toll-free) 1-866-PSC-UTAH (1-866-772-8824) to receive a bridge number and participant passcode. Participants attending by telephone should then call the bridge number five minutes before the hearing, entering the passcode followed by the # sign to ensure participation.

In accordance with the Americans with Disabilities Act, individuals needing special accommodations (including auxiliary communicative aids and services) during the hearing should notify the PSC at 160 East 300 South, Salt Lake City, Utah 84111, (801) 530-6716, at least three working days prior to the hearing.
